Public Hearing in regard to Testimony and Evidence Presented from any Lienholder, Mortgagee, Property Owner (Gina Marie Garcia) and City Officials Regarding the Structures Located on Property in the Kenedy Addition; Block 45; 60 ft of Lot 1 and 45 ft. of SE part of lot 2; also known as 623 Escondido Street; to Determine if the Structures are in Violation of Ordinance 17-3 and Should be Considered a Dangerous Building and Possible Action and/or Abatement of a violation not excluding demolition.

Mayor Garza opened the public hearing at 7:10 p.m.

Lanny Holland was sworn in by Mayor Garza. Lanny Holland, Building Official, stated he sent notice to the property owner twice via certified mail. Mr. Holland also published the notice in the local newspaper on two occasions. Documentation and photos of building were provided. Lanny Hollands recommends to demolish the dangerous structure. If passed, decision will be reviewed in 30 days to provide owner adequate time to appeal to City Council.
