7. Consideration and possible action authorizing the City Manager to give an extension of time to Karnes County Humane Organization (KCHO) for compliance, initiate a zoning ordinance amendment to address animal shelters and kennels as permitted uses and any other matters related to KCHO compliance issues.

Mayor James Sutton requested the Council convene into closed session to consult with the City Attorney.

Councilor Brenda Cano made a motion to convene into closed session. Motion failed.

Councilor Justin Meyer made a motion to discuss authorizing the City Manager to give an extension of time to Karnes County Humane Organization (KCHO) for compliance, initiate a zoning ordinance amendment to address animal shelters and kennels as permitted uses and any other matters related to KCHO compliance issues. Leslie Wynn seconded the motion. All voted in favor. Motion passed.

Councilor Justin Meyer suggested a one-year extension with a six-month benchmark to acquire land.

Building Official Jaime Albiar stated there were issues with the tire shop being converted to a kennel. A permit nor a Certificate of Occupancy were ever issued for KCHO. Councilor Leslie Wynn asked what is needed to obtain a Certificate of Occupancy. Jaime stated not much will be needed for them to be in compliance.

Councilor Justin Meyer made a motion to table agenda item #7. Councilor Leslie Wynn seconded the motion. All voted in favor. Motion passed.

Councilor Justin Meyer made a motion to convene into closed session to consult with the City Attorney. Councilor Brenda Cano seconded the motion. All voted in favor. Motion passed.

They also have 30 days to get in compliance with the City of Kenedy. Councilor Leslie Wynn seconded the motion. All voted in favor. Motion passed.

Councilor Justin Meyer directed staff to create a planning and zoning plan to allow to add changes for kennels, animal shelters, and facilities for permitted uses in the City of Kenedy.

City Attorney Megan Santee provided Council with a draft agreement in compliance with statutory requirements.
