Consideration and possible action in regard to Resolution 20-24, a Resolution of the City of Kenedy, Texas, authorizing the submission of a Texas Community Development Block Grant Program Application to the Texas Department of Agriculture for the Fire, Ambulance, and Service Truck (FAST) Fund; and authorizing the Mayor and/or City Manager to act as the City's Executive Officer and authorized representative in all matters pertaining to the City's participation in the Texas Community Development Block Grant Program.

Consideration and possible action in regard to the selection of a grant administrator for administration of the Texas General Land Office (GLO) Community Development Block Grant Disaster Recovery-Mitigation (CDBG-MIT) Program and authorize the city manager to enter into a professional services agreement for grant administration with the selected firm.
12. Consideration and possible action in regard to the selection of an engineer for the Texas General Land Office (GLO) Community Development Block Grant Disaster Recovery-Mitigation (CDBG-MIT) Program.
