
Special Accommodations

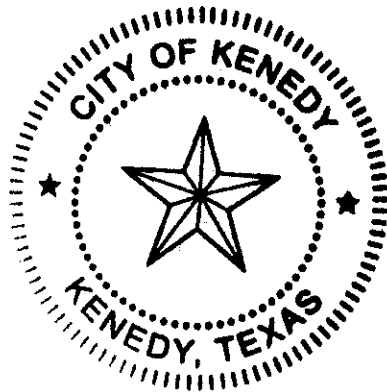

Opening Agenda

1. **Call Regular Parks and Recreation Board meeting to order and establish a quorum is present.**

President Nunez called the meeting to order at 6:35 p.m. and announced a quorum was present.

2. **Welcome Guests.**

President Nunez welcomed Joe Hernandez to the meeting.

3. **Citizen comments.**

No citizens present.

4. **Discussion and approval of regular minutes for May 25, 2021.**

Motion: Vice President Sandoval moved to approve the May 25, 2021 minutes as presented. Lucille Matthews seconded the motion. Motion carried unanimously.

5. **Old Business**

- A. **Discussion and possible action on Glenna May bench for Joe Gulley Park.**

Discussion was held among the board on the Glenna May bench for color, plaque, and price.

Motion: President Nunez moved to remove the motion Gerardo Salas made on May 25, 2021 to make the bench red. Lucille Matthews seconded the motion. Motion carried unanimously.

Motion: Vice President Sandoval moved to make the Glenna May bench color black. Lucille Matthews seconded the motion. Motion carried unanimously.

Motion: President moved to purchase two plaques, one for the bench and one for a rock at the Joe Gulley Park. The plaque will state “In Memory of Glenna May”. Vice President Sandoval seconded the motion. Motion carried unanimously.

Motion: President Nunez moved to remove the motion made on May 25, 2021 for the bench price of \$1385.00. Lucille Matthews seconded the motion. Motion carried unanimously.

Motion: President Nunez moved to approved the amended price for the Glenna May bench to \$1,696.70 to include the shipping. Lucille Matthews seconded the motion. Motion carried unanimously.

B. Tabled on May 25, 2021: Discussion and possible action on landscaping around the gazebo at Joe Gulley Park.

Motion: Vice President Sandoval moved to table discussion and possible action on landscaping around the gazebo at Joe Gulley Park till the next meeting on July 20, 2021. Lucille Matthews seconded the motion. Motion carried unanimously.

C. Tabled on May 25, 2021: Discussion and possible action on reseeding Blue Bonnets for Joe Gulley Park.

Motion: President Nunez moved to table discussion and possible action on reseeding Blue Bonnets for Joe Gulley Park till the next meeting on July 20, 2021. Vice President Sandoval seconded the motion. Motion carried unanimously.

D. Discussion regarding possible inspection and board replacement on the bridge at Joe Gulley Park.

Parks & Streets Director Joe Hernandez stated an inspection was conducted and ninety (90) boards will be needed for repair on the bridge and the gazebo.

Motion: Vice President Sandoval moved to obtain a quote for repairs for board replacement on the bridge and gazebo at Joe Gulley Park. President Nunez seconded the motion. Motion carried unanimously.

E. Discussion and possible action regarding replacement of old cables on the windmill.

President Nunez stated was in contact with Robert Janysek, Water Well Service Company, who worked on the windmill previously. Janysek has been asked to provide a quote on replacement of old cables on the windmill.
